## **Clean Energy**

Clean Energy Jobs Act (Williams/Castro) -- The Clean Energy Jobs
Act would lead Illinois to 100% clean energy by 2050, decarbonize our
power sector, reduce pollution from the transportation sector and
ensure job training and equitable clean energy development-- all while
lowering bills, and preventing fossil fuel bailouts.

### **Nutrient Loss Reduction Strategy**

- Excessive levels of nutrients are degrading the quality of streams, rivers, and lakes within Illinois and contributing to the dead zone in the Gulf of Mexico.
- The Strategy sets a milestone to reduce nitrogen in Illinois waters by 15% and phosphorus by 25% by 2025.
- Additional resources are needed to administer and implement the Strategy in order to meet the Strategy's 2025 milestone. These include resources needed for reporting, research, water quality monitoring, technical assistance through the Illinois Department of Agriculture and Illinois Extension, for Soil and Water Conservation Districts throughout the state, and to provide cost-share funding for nutrient capture projects on farmland, including on the state's lands leased for agriculture.

#### Partners for Nutrient Loss Reduction Act

- The Illinois Partners for Nutrient Loss Reduction Act extends and increases funding for the Partners for Conservation Fund to fiscal year 2026.
- Legislation adds a new purpose and increases funding to the Partners for Conservation Fund in order to implement Illinois' Nutrient Loss Reduction Strategy. (Current funding is through fiscal 2021.)
- Cost to Achieve The ultimate target for each Mississippi River Basin state is a 45% reduction in both phosphorus and nitrogen. The estimated cost to achieve this target in Illinois is \$800 million per year. SB3462 will ramp up funding to implement the Strategy over the next six years in order to first meet the 2025 milestone. It calls for \$138 million to be invested in Strategy implementation, from \$18.135 million in year 2021 up to \$25.7 million in 2026.

## **Conservation and Open Space**

- Partners for Nutrient Loss Reduction Strategy Act (Villivalam/Vella) -- In order to address the state's difficulties with implementing the Nutrient Loss Reduction Strategy, this legislation would add implementation of the strategy to the purposes of the Partners for Conservation Fund (which must be reauthorized this session) and provide additional fiscal resources to agencies implementing the strategy.
- Ban on Bobcat Hunting (Didech/Holmes) -- Prohibits the hunting of bobcats in Illinois.

## Sustainable Agriculture

- Farming as a public service HR 5 (West) -- Urges Congress to add farming as a public service to support debt forgiveness for young farmers.
- Good Food Purchasing Policy Task Force (Resolution- Harper) -- Creates a task force made up of procurement heads of majority of State agencies, along with private partners in the sustainable/equitable agriculture movement, to examine current food procurement and find what changes are needed to encourage more locally sourced food that is both sustainable and equitable.
- Ban Pre-Treated Seeds in Ethanol Production (Villa/?) -- Bans the use of pretreated seeds (i.e. coated with pesticides) in the production of ethanol.
- Protecting Pollinators (Guzzardi/Villa) -- Sets reasonable restrictions on the use of neonicotinoids pesticides
  on State property, limiting it to use in structural pest control and mitigation of emerald ash borer. This also sets
  these types of pesticides as "Restricted Use", meaning that they can only be purchased and used by licensed
  pesticide applicators.
- Local Food Producers (Guzzardi/Koehler) Expands the current cottage food laws to allow direct-to-consumer sales, including sales online within Illinois. This also clarifies the type of products which can be produced, namely canned items, as long as they follow USDA health guidelines.

## **Clean Air, Liveable Communities**

Environmental Justice Permitting -- IEC will be working with the Chicago Environmental Justice Network on legislation that addresses loopholes in permitting that currently exacerbate pollution in burdened communities.

#### What is 30x30?

- The United Nations Convention on Biological Diversity estimates that the conservation of 30% of the land and water in the world by 2030 in order to achieve mitigation goals established under the Paris Climate Agreement
- In 2019 Senator Udall introduces a resolution affirming that the United States should establish policies putting us on the path towards achieving this goal in the United States
- On January 27th President Biden signs an Executive Order directing federal agencies to begin
  assessing how the United States can achieve the 30x30 goals as part of broader climate change
  initiatives, including the reintroduction of the US into the PAris Climate Accord
- So, what does that leave Illinois?

percent of its land and 30 percent of its ocean areas by 2030.


